**Site Address:** Land to the East of the A48 (Coordinates E257386, N209389) and Land to the South West of Tycroes (Coordinates E259219, N209551; & E259904, N209590), Carmarthenshire

Between 06 May 2020 and 03 June 2020, the Planning Inspectorate for Wales (the Inspectorate) received various submissions relating to the above Developments of National Significance (DNS) application. The original date by which the Inspectorate was to confirm our 'acceptance' of this application, or to confirm that the application is not accepted, was 01 July 2020.

However, due to unforeseen circumstances related to the Covid-19 pandemic, it appears that the relevant Local Planning Authority (LPA) are currently unable to engage with the DNS system. In these circumstances, the Welsh Government's Planning Directorate has requested that we extend the acceptance period.

In accordance with Article 15(7)(b) of The Developments of National Significance (Procedure) (Wales) Order 2016 (as amended), I hereby extend the acceptance period for this application by 4 weeks. The end of the acceptance period is now therefore 26/08/2020.
