All representations will be published to the website (link above). However, I would like to re-assure you that personal details such as e-mail addresses and telephone numbers will not be made available to members of the public.

The appointed Inspector will determine the procedure the application will follow within 10 working days of the close of the representations period after considering the responses that have been received. The procedure will be updated on the website once it has been confirmed. If a Hearing or Inquiry session is needed, the Inspector will invite those whose presence he / she considers necessary and only they will be entitled to participate. However, a Hearing or Inquiry will be a public event and, as such, you are welcome to attend and observe proceedings.

Should you wish to receive a copy of the Minister's Decision in due course, you should request one in writing.
